Water Sustainability Projects

2021 CAP Storage – All 9,960 acre-feet (AF) of the District's CAP order has been delivered as of the end of October. All of the District's order for 2021 was delivered to groundwater savings facilities (GSF). The City of Phoenix has ordered 3,500 AF of water to be delivered to AVRP, which started on July 1, 2021. All of Phoenix's water was delivered to AVRP by December 18, 2021.

South Shannon Treatment System Reimbursements – Since 2000, \$1,427,193.45 has been reimbursed by the Arizona Department of Environmental Quality (ADEQ). For Fiscal Year 2022, ADEQ has a budget of \$61,234 for operations and sampling, and \$43,260 for two GAC change outs of the South Shannon Treatment System. The invoice for December 2021 and January 2022 will be submitted in February after the meter reconciliation work is completed between December and January.

Capital Improvement Program & Other Major Projects

Northwest Recharge, Recovery, and Delivery System (NWRRDS)

The consultant is working on the final design of the transmission main and forebay. The final package is expected in January. Staff and the District's consultants are working on the various permits required for construction.

The final package for the well equipping and collector pipelines has been received. Staff are performing a back check of comments. Staff and the District's consultants are working on the various permits required for construction.

Staff intended to procure construction of well equipping/collector pipeline, the transmission main, and forebay using a two-step process. Step one was to pre-qualify construction firms and only allow the pre-qualified firms to provide bids in Step 2. Based upon further review, it was determined that a single-step process should be utilized. Staff is preparing the bid notice and construction documents.

In lieu of a meeting, a status update was sent to the Partners on December 22, 2021.

NWRRDS (Metro-only portion)

Comments on the Metro Independent Transmission Main were received from Pima County on December 27, 2021, which staff are reviewing now. Staff are preparing the bid notice and contract documents.

E&T22 Well Replacement – Land acquisition activities are ongoing.

Ironwood Well Site Acquisition – Land acquisition activities are ongoing.

Pantano Road Transmission Main – Staff are finalizing the design drawings and contract documents in preparation for bidding for construction beginning in the first part of Fiscal Year 2023.
