Water Sustainability Projects

2018 CAP Storage – Storage at Avra Valley Recharge Project (AVRP) as of February 28, 2018 was 108 AF for the District and 500 AF for the City of Phoenix. The District’s GSF partners have stored 200 AF for the District and 60 AF at the Southern Avra Valley Recharge and Recovery Project for Metro Southwest – Lazy B.

South Shannon Treatment System Reimbursements – Since 2000, \$1,125,820.74 has been reimbursed from Arizona Department of Environmental Quality (ADEQ).

Avra Valley Recharge Project – The AVRP Underground Storage Facility Permit and Water Storage Permit applications are complete and were submitted to ADWR on March 6, 2018.

Capital Improvement Program & Other Major Projects

RTA Waterline Relocation – La Cholla Blvd: Overton Road to Lambert Lane – Staff is finalizing the design work and preparing contract documents for bidding. The Pima County/Oro Valley design consultant has finalized the roadway plans, changes have been incorporated into the water plans, and the water plans have been provided to the design consultant for review/approval. Right-of-way has been acquired for a portion of the project and it is anticipated that the remaining right-of-way acquisition will be completed in June 2018. Construction may be phased due to the status of right-of-way.

RTA Waterline Relocation – Valencia Road: Wade Road to Ajo Highway, Waterline Relocations – Construction is complete and project closeout is underway.

Northwest Recharge, Recovery, and Delivery System (NWRDRS) Land Acquisitions Easement acquisition and coordination with the Arizona State Land Department is ongoing. The request for qualifications for program support services closed March 5, 2018 and the evaluation of the submittals received is anticipated to be completed by March 28, 2018.
