**Approval of Amendment No. 2 for the Analytical Laboratory Services
Contract for Inorganic Chemical (IOC) Analyses**

Synopsis

The Board of Directors is requested to approve Amendment No. 2 for the Analytical Laboratory Services contract for Inorganic Chemical (IOC) Analyses with Eurofins Eaton Analytical LLC (formerly Eurofins Eaton Analytical, Inc.), to increase the contract amount and extend the contract through Fiscal Year 2020.

Background

The Arizona Department of Environmental Quality (ADEQ) enforces federal drinking water requirements of the Safe Drinking Water Act. Water quality testing services necessary to maintain compliance with ADEQ Drinking Water Rules and to ensure the delivery of safe reliable water to customers must be performed by a qualified laboratory.

With Amendment No. 2, the contract would not exceed \$53,000. This cost includes compliance sampling for Metro Main, Metro Hub and Metro Southwest service areas and some contingency sampling. The contract expiration date would change to June 30, 2020 with this Amendment.

Issues

Based on ADEQ drinking water regulatory requirements to analyze for IOCs, the District requires the renewal of the Analytical Laboratory Services Contract for IOCs for Fiscal Year 2020. In June 2017, the Board of Director's approved the Inorganic Chemical Analytical contract with Eurofins Eaton Analytical LLC. This would be the third year of the contract, pending Board approval.

It is anticipated that for Fiscal Year 2020, an additional \$8,000 of funding will be required for the IOC analytical services contract (see Table 1).
