Approval of Amendment No. 2 for the Analytical Laboratory Services Contract for Volatile Organic Chemical (VOC), Total Trihalomethane (TTHM) and Haloacetic Acid (HAA5) Analyses

### **Synopsis**

The Board of Directors is requested to approve Amendment No. 2 for the Analytical Laboratory Services Contract for Volatile Organic Chemical (VOC), Total Trihalomethane (TTHM) and Haloacetic Acid Analyses (HAA5) with Turner Laboratories, Inc., to increase the contract amount and to extend the contract through Fiscal Year 2020.

#### **Background**

The Arizona Department of Environmental Quality (ADEQ) enforces federal drinking water requirements of the Safe Drinking Water Act. Water quality testing services necessary to maintain compliance with ADEQ Drinking Water Rules and to ensure the delivery of safe reliable water to customers must be performed by a qualified laboratory.

With Amendment No. 2, the contract would not exceed \$83,000. This cost includes compliance sampling for Metro Main, Metro Hub and Metro Southwest service areas and some contingency sampling. The contract expiration date would also change to June 30, 2020 with this Amendment, but would include the option to extend the contract an additional year with Board approval.

#### <u>Issues</u>

Based on ADEQ drinking water regulatory requirements to analyze for VOCs, TTHM and HAA5 Analyses, the District requires the renewal of the Analytical Laboratory Services contract for VOCs, TTHMs and HAA5 for FY 2020. In June 2017, the Board of Director's approved the VOCs, TTHM and HAA5 Analyses contract with Turner Laboratories, Inc., with the ability to extend the contract two additional years. This is the third year of the Contract, pending Board approval.

It is anticipated that for Fiscal Year 2020, \$23,000 of additional funding will be required for the VOC, TTHM and HAA5 analytical contract (see Table 1).
