Water Sustainability Projects

2017 CAP Storage – Storage at AVRP as of May 31, 2017 was 2,022 AF of the 3,450 AF for the District and 1,600 AF of the 3,500 AF for the City of Phoenix. The District's GSF partners have stored 7,031 AF for the District, 500 AF has be stored at the Lower Santa Cruz Recharge Project, and 9 AF at the Southern Avra Valley Recharge and Recovery Project for Metro Southwest – Lazy B.

South Shannon Treatment System Reimbursements – Since 2000, \$1,092,645.14 has been reimbursed from Arizona Department of Environmental Quality (ADEQ). June 2017 reimbursements were submitted to ADEQ.

Oracle Jaynes Replacement Well – Stewart Brothers completed all drilling, well installation, and testing portions of the project on June 8, 2017. Clear Creek Associates delivered the final well installation report on June 30, 2017. The well capacity is 600 - 800 gallons per minute. Of the water quality analytical reports received thus far, the water produced will meet all SDWA standards.

Capital Improvement Program & Other Major Projects

Oracle Jaynes Replacement Well Equipping and Site Improvements – Staff continue the process of soliciting cost proposals from J.O.C. and on-call contractors and suppliers for provision of site improvements, including the well pump, mechanical and electrical components, site grading and fencing.

RTA Waterline Relocation – La Cholla Blvd: Overton Road to Lambert Lane – Staff is continuing their design work while coordinating with Pima County/Oro Valley and their design consultant. Stage IV (pre-final) roadway improvement plans have been received from the County's/Oro Valley's design consultant. Final roadway design is expected by late June 2017.

RTA Waterline Relocation – Valencia Road: Wade Road to Ajo Highway, Waterline Relocations - Staff are continuing design work while coordinating with Pima County and their design consultant. "Final for Utilities" roadway plans were issued in early May. Pima County is requesting all relocation work to be completed by December 2017.

Northwest Recharge, Recovery, and Delivery System (NWRRDS) Land Acquisitions – Staff continues to pursue easements necessary for the pipeline route. Staff and consultants are completing surveys/studies and assembling the necessary documents in order to make a formal submittal to the Arizona State Land Department for acquisition of the necessary easements and parcels.
