## **System Maintenance**

Noteworthy Maintenance Projects and Major Repairs in August 2024:

- 1. E&T22 the new diesel generator was wired and is fully operational.
- 2. Deconcini well pulled and is awaiting brush and bail from Smyth.
- 3. Shannon well installed the new power supply for the Advanced Oxidation Process and new flow meter. Currently flushing before placing the well back online.
- 4. Staff repaired an 8" main break at Nanini Drive and Oracle Road.
- 5. Staff installed regenerated media for arsenic treatment at Hub #3, removed exhausted media, and is prepping exhausted media to ship off to be regenerated.

### **Water Sustainability Projects**

**2024** CAP Storage –All of the District's 8,460 acre-feet of ordered CAP water will be delivered in 2024 to groundwater savings facilities (GSF). As of the end of July, 6,560 acre-feet of the District's order has been delivered to the CMID and Kai Farms Red Rock GSFs.

The City of Phoenix's revised order is for 5,000 acre-feet of CAP water to be delivered to AVRP in 2024. As of the end of July, 3,634 acre-feet of Phoenix's order has been delivered to AVRP.

**South Shannon Treatment System Reimbursements** – Since 2000, \$1,683,680.42 has been reimbursed by the Arizona Department of Environmental Quality (ADEQ). The well will be fully operational and the full treatment system will be pumping water to the system in September.

# Capital Improvement Program & Other Major Projects

**Northwest Recharge, Recovery, and Delivery System (NWRRDS) (Partnered portion)** Borderland continued installation of the transmission main along Avra Valley Road east of the Marana Regional Airport with two separate crews. Borderland also began construction of the well collector pipeline. Acquisition of easements to accommodate the realignment portion of the transmission main within the TGI I-10 Land Partnership parcels is pending acceptance by the land owner.

**NWRRDS** (Metro-only portion) Granite completed the pipeline installation and is finalizing the tie-in at the Herb Johnson Reservoir.

**Ironwood Well** – Staff is continuing with the well equipping civil design work. Carollo's electrical and security design is ongoing with input from staff.

Rose Marie Lane – Staff is continuing with preliminary design activities and is preparing documents for solicitation. This project is anticipated to replace approximately 600 feet of 2" galvanized pipeline.
