## **Water Sustainability Projects**

**2016 CAP Storage** – All of the scheduled 3,950 acre-feet (AF) was recharged for the District at Avra Valley Recharge Project (AVRP) as of September 30, 2016. Additionally, 179 AF of the 1,100 AF scheduled for storage by the Arizona Water Banking Authority and all of the 1,500 AF for the City of Phoenix has been stored. All of the 7,912 AF scheduled for storage at the District's groundwater savings facility (GSF) partners has been completed for 2016 as well as the 50 AF stored at City of Tucson's Southern Avra Valley Recharge and Recovery Project.

**South Shannon Treatment System Reimbursements** – Since 2000, \$1,079,700.02 has been reimbursed from Arizona Department of Environmental Quality (ADEQ). Reimbursements for September are pending from ADEQ.

**South Shannon Water Quality Assurance Revolving Fund (WQARF) Site** – Staff met with ADEQ's consultant on October 26, 2016 for a presentation of groundwater cleanup options. Tucson Water also attended and after the presentation, 1,4-Dioxane was discussed. ADEQ agreed to meet again with both Metro Water and Tucson Water to more fully understand the extent of 1,4-Dioxane.

**Cortaro-Marana Irrigation District (CMID) Effluent Groundwater Savings Facility Project** – Advertisement for the construction of the project was completed with bids received on October 20, 2016. Pima County did not act on the approval of the IGA during their October 18, 2016 Board meeting and will reconsider the IGA during their December 2016 meeting. Award of the construction contract will be delayed.

**Oracle Jaynes Replacement Well** – Staff approved a scope of work from Clear Creek Associates for assisting with the drilling project. Clear Creek Associates is working on reviewing the technical specifications at this time.

### **Capital Improvement Program & Other Major Projects**

Casas Adobes Estates MLP (Nanini Drive, Casas Adobes Drive, and Andrea Doria Drive) – Construction acceptance occurred on September 14, 2016 and project close-out continues.

### CAP Recharge, Recovery, and Delivery System (RRDS) Land Acquisitions

- Booster Station Property Closeout of the acquisition agreement occurred on June 30, 2016.
- Redpoint Development Easements The Town of Marana, Redpoint Development and the District met regarding set back requirements along the future alignment of Lambert Lane. A Memorandum of Understanding (MOU) has been prepared and sent to Redpoint for approval before being submitted to the Town of Marana. Legal descriptions have been finalized.
- State Land Easements The process to acquire easements and any necessary land from the Arizona State Land Department is expected to take approximately two years to finalize and has been initiated. With the relocation of the project wells to State lands, new

cultural and environmental reports, and survey (legal descriptions) are required to submit to State Land. Tierra has commenced the required work.

- Town of Marana Easement The easement legal description on the airport property is complete and the easement request has been submitted to the Town of Marana.
- Pima County Easements Pipeline easements from eight parcels owned by Pima County are necessary for the project. Legal descriptions had to be revised due to right of way issues. District staff is investigating a proposed realignment of Avra Valley Road near I-10 by ADOT and will be meeting with Pima County Flood Control soon.
- Cal Portland Cement Company Easement legal description and appraisals have been submitted.
- Residential Lot Easements Approximately 30 pipeline easements are necessary from residential lots for the project. Easement legal descriptions are being finalized for the areas that the pipeline alignment is known. The market analysis for the easement valuations in this area has been completed. Tierra has begun submitting the easement requests to these properties and begin negotiations with the private property owners. Several easement acquisitions have been finalized. The District will not know the final pipeline alignment for the area between Blue Bonnet Road and Camino de Oeste until potential project partners' participation is known.
