Water Sustainability Projects

2021 CAP Storage – The District has ordered 9,960 acre-feet of its allocation to be delivered to groundwater savings facility (GSF) partners in 2022 with the remaining 3,500 acre-feet of the District's allocation delivered to CAP for use in the 500 Plus Plan as additional system conservation beyond what the DCP requires of the state. As of August 31, 2022, all of the District's CAP order has been delivered to GSF partners.

The City of Phoenix has ordered 3,500 acre-feet of CAP water to be delivered to AVRP in 2022. Deliveries of Phoenix water began at AVRP in June after facility improvements were completed. All of Phoenix's water was delivered before the CAP canal shutdown in October. In addition to the 3,500 AF of Phoenix's water, 159 acre-feet was over delivered to the AVRP facility. This volume will be accounted for as Phoenix water, at no financial impact to the District. An equal volume will not be delivered to a GSF in Maricopa County that is operated by New Magma mining company.

South Shannon Treatment System Reimbursements – Since 2000, \$1,507,428.68 has been reimbursed by the Arizona Department of Environmental Quality (ADEQ). For Fiscal Year 2023, ADEQ has a budget of \$63,071 for operations and sampling, and \$44,558 for two GAC changeouts of the South Shannon Treatment System. The invoice for October 2022 will be submitted in mid-November. The installation of the designed Advanced Oxidation Process system is expected to occur during Fiscal Year 2023. This will allow the operation of the South Shannon well at full capacity, and capture/treat the contaminant plume more efficiently.

Capital Improvement Program & Other Major Projects

NWRRDS (Partnered portion)

A kick-off meeting was held with the District's miscellaneous design consultant to complete a constructability and cost review of the existing design. The intent is to identify potential cost-savings measures for construction. The draft report is anticipated by the end of November. District staff are evaluating design options at the Avra Valley / I-10 crossing due to a recent abandonment by Pima County of a portion of the right-of-way where the transmission main was proposed to be located. The outcome of staff's evaluation will be included in any future redesign efforts resulting from the constructability and cost evaluation.

NWRRDS (Metro-only portion)

The consultant is finalizing the report and plan for the Landscape and Native Plant Mitigation Plan to satisfy a requirement by Pima County. A coordination meeting was held between the partners to discuss the timing of the review submittal for the parallel portions of the independent booster and pipeline projects to the Town of Marana and Pima County.

E&T22 Well Replacement – Land acquisition activities are ongoing. Currently waiting for HUD approval of the release of the reverse mortgage. A schedule and cost proposal

was requested from well drilling contractors via the City of Tucson Job Order Contract. Bids were received November 7, 2022 from two contractors. The Board of Directors will be requested to consider action at the November 14, 2022 meeting.

Ironwood Well – Land acquisition activities are ongoing. Staff is reviewing the closing documents. A schedule and cost proposal was requested from well drilling contractors via the City of Tucson Job Order Contract. Bids were received November 7, 2022 from two contractors. The Board of Directors will be requested to consider action at the November 14 meeting.

New Linda Vista Well Deepening – A schedule and cost proposal was requested from well drilling contractors via the City of Tucson Job Order Contract. Bids were received November 7, 2022 from two contractors. The Board of Directors will be requested to consider action at the November 14, 2022 meeting.
