## **Billing Adjustments**

## Report

During May 2013, the customers listed below were given an adjustment for water charges abnormally high water use as based on the policies approved by the Metro Water District Board of Directors. Documentation of each adjustment is on file with Customer Service. In most circumstances the adjustment is limited to \$100 but extraordinary situations are reviewed on a case by case basis and adjusted as per final decision of the General Manager. At the January 14, 2008 meeting the Board did reinstate the authorization of adjustments for commercial accounts but not to exceed \$500. The amount the customer paid for water charges after the adjustment is shown in the last column of the table below. Commercial accounts noted in **bold print.**
