

# DUAL METER AGREEMENT AND RIGHT OF ENTRY

## DEFINITION:

A Dual Meter is a meter configuration that allows outdoor water uses to be subtracted from the total water usage in the calculation of sewer fees and billing. This is accomplished by the installation of a separate water meter tapped within five (5) feet down stream of the existing water service. A Dual Meter is applicable only to an existing residential meter installation.

The Meter Assembly consists of an upstream  $\frac{3}{4}$  angle meter stop, spool piece (to be replaced with the dual meter once installed), downstream  $\frac{3}{4}$  angle meter stop, and  $\frac{3}{4}$  dual check valve.

## ACKNOWLEDGEMENTS:

Owner/Grantor of the property in which the Dual Meter is installed upon agrees and affirms that the water use from this meter will be for outdoor water uses only (irrigation, garden hose, and pools) and will not be used in any manner that will permit its entry to the public sanitary sewer system. Violation of these requirements will be cause for Metropolitan Domestic Water Improvement District (GRANTEE) to remove the dual meter and all water usage will be subject to sewer charges.

OWNER/GRANTOR is responsible for the installation and maintenance of all piping and connections before, after, and to the Meter Assembly.

GRANTEE will supply the parts of the Meter Assembly at the time of this agreement, and once all applicable fees are paid.

GRANTEE will retain ownership of the Meter Assembly once installed.

OWNER/GRANTOR is responsible for the installation of the Meter Assembly per the attached detail.

Upon installation, OWNER/GRANTOR will notify GRANTEE who will inspect the installation, install and activate the dual meter, verify of correct operation of the irrigation connections, and set the meter box.

OWNER/GRANTOR can elect to discontinue the Dual Meter program at any time, though re-activation of the dual meter will be subject to current service charges and connection fees, and may require re-verification of irrigation connections. Transfer/Change of property ownership will render this agreement null and void, and require all successors or assigns to grant further continuance of the Dual Meter program via a separate agreement.

## FEES:

“Meter Fee” from the current Water Service Connection Fee schedule (includes meter, meter box, all inspections and activation) as published on the District website.

## RIGHT OF ENTRY:

The OWNER/GRANTOR hereby grants to GRANTEE, and its representatives and authorized agents, permission to enter upon the aforementioned property for the purpose of installation, reading, and maintenance of the dual meter.
