Collaborative Water Exchange



Metro Water District and The City of Phoenix have developed an innovative water management agreement for the storage and exchange of Central Arizona Project water, known as Inter-AMA Firming. The City of Phoenix has a similar agreement with the City of Tucson. On September 8, 2014, the District Board of Directors approved an intergovernmental agreement (IGA) between the City of Phoenix and the District for Inter-AMA (Active Management Area) Municipal & Industrial (M&I) Firming, otherwise known as Inter-AMA Firming. The District and Tucson Water each developed IGAs with the City of Phoenix for implementing a pilot phase of Inter-AMA Firming. The pilot successfully tested the feasibility of Inter-AMA Firming with the State Agencies by storing and recovering a small portion of water.

On October 12, 2016, the District Board of Directors approved an amendment to the IGA pertaining to CAP water storage for a period of two years. The City of Phoenix will annually store up to 3,500 acre-feet (the amount of water that covers one acre with one foot of water) of their CAP allocation at the District's Avra Valley Recharge Project beginning January 1, 2017 and ending December 31, 2018. This agreement is financially beneficial for the District, generating approximately \$110,000 annually, and provides Phoenix a greater degree of certainty in light of future expected shortages on the Colorado River.

## METRO WOWS! WITH REVENUE STABILITY PRESENTATION

On September 20, 2016, General Manager Joe Olsen had an opportunity to talk about revenue stability at the Alliance for Water Efficiency conference in Phoenix. Mr. Olsen shared how the District arrived at 90% fixed cost recovery to over 100 water and financial leaders as well as with elected officials. The presentation generated great enthusiasm with some of the attendees embracing Metro's revenue stability concepts for implementation within their own organizations and municipalities. •
